**ARTICLE A1.000**  
**MISCELLANEOUS FEES**

**§ A1.001. Permit for use of outdoor sound amplification equipment.**

A permit for the amplification of music or human speech requires payment of a \$10.00 fee for the administrative costs of issuing the permit or a sworn statement of inability to pay the fee.

**§ A1.002. Notary fees.**

Fees for notary services are as follows:

- (1) First notary signature: \$10.00.
- (2) Each additional signature per document: \$1.00.

**ARTICLE A2.000**  
**ANIMAL CONTROL FEES**

**§ A2.001. Livestock permit.**

(a) The permit fee to keep livestock in the city is \$75.00.

(b) The renewal fee is \$75.00.

**§ A2.002. Registration of dangerous dog.**

(a) Annual fee. The annual fee for registration of a dangerous dog is one hundred dollars (\$100.00).

(b) Transfer of registration. There shall be a fee of twenty-five dollars (\$25.00) for issuance of a new registration tag if an owner of a registered dangerous dog sells or moves the dog to a new address.

**ARTICLE A3.000**  
**BUILDING AND DEVELOPMENT RELATED FEES**

**§ A3.001. Building permits.**

Fees for building permits are as follows:

- (1) \$100.00 for original permits for residential structures to include tiny home, manufactured home and stick-built home.
- (2) \$50.00 for renewal permits for residential structures.
- (3) \$75.00 for all external additions on existing structures to include attached and freestanding garages, carports and storage.
- (4) \$50.00 for RV parking permit.
- (5) \$200.00 for original permits for commercial structures.
- (6) \$100.00 for renewal permits for commercial structures.

**§ A3.002. Dirt hauling.**

Fees for hauling truck load of dirt.

- (1) Delivery only: \$350.00.

**§ A4.001. Mobile food vendors.**

- (a) Mobile food vendor permits will be issued for the following periods of validity, each with the respective application fees:
  - (1) Daily: \$25.00 per day.
  - (2) Monthly: \$100.00 per month.
  - (3) Yearly: \$300.00 per calendar year.
- (b) Upon renewal of a mobile food vendor permit issued for one year, the applicant shall pay a renewal fee of \$250.00.
